EXPENSES MORE THAN DOUBLE THE ALLOCATION

PMC's annual budget falls short of meeting medical expenditure of staff, ex-corporators

THE PUNE Municipal Corporation's tall claims of a 're-alistic' annual budget for the fis-cal 2023-24 have fallen flat as the provision for medical expenses of its staff, retired staff and foror its stair, retired stair and for-mer corporators was exhausted within a few months of the fi-nancial year as the new projec-tion is triple that of what it had estimated for the year.

The civic administration had made a budgestary provision of 82 do control recurring medical expenditure of its staff and rectired staff, which includes paying part bills of hospitalization in registered private hospitals. The PMC has received bills worth Rs 19 crore from private hospitals for medical treatment of civic staff and retired staff. A payment of Rs 1651 crore has been done to clear the bills of February-March of the previous financial year and April-May of

The civic chief has moved a proposal, seeking diversion of 8x 40 crore to bear the medical expenditure of staff and retired staff for the remaining part of this financial year. There is a need of total Rx 59 crore to bear the medical expenditure of the current and the retired staff, said the civic chief. The PMC had made a budgetary provision of Rx 40 crore to start health insurance policy for civic staff, retired

staff and former corporators. However, that money has not been spent as of now and is un-likely to be spent this financial year. So, the amount should be transferred to pay for the med-ical eyear.

The PMC had also set aside RS 2 crore to bear the medical expenditure of former corporators but the amount lasted only till July while a claim of RS 1.57 crore needs to be cleared.

Eye experts raise concern over harmful effects of laser lights used during festivals

THE LARCE-SCALE use of high-powered laser lights during the recently concluded Canesh fes-tival has flagged concerns among ophthalmologists with experts stating that the retina isvulnera-ble due to the focusing power and direct exposure to such lights.

Addressing a media confer-

hts, Addressing a media confer-Addressing a media conter-ence on Tuesday, Dr Anil Dudhabhate, an ophthalmolo-gist based in Pune and retina spe-cialist, said exposure to high-powered lasers can lead to retinal hemorrhage. "Anyone who focuses on a laser of 5 MW for even ten sec-

laser of 5 MW for even ten sec-onds can suffer from retinal hemorrhage," said Dr Dudhabhate adding that it can have a blinding effect. He cited the example of a 23-year-old man, who suffered retinal damage due to exposure to high-fre-quency laser and has lost 70 per cent vision in his eye, which could not be restored even after surgery. Dr Dudhabhate said that the man's blood vessel burst, due

"Many have suffered sympons like dry eye and swelling

due to exposure to the laser

beams," said Dr Dudhbhate. Dr Parikshit Gogate, former president of the Maharashtra Ophthalmologists Society, said the bright-coloured lasers are bad for the eyes, ears and brain. "Flashing a lot of this bright light

"Flashing alot of this bright light into the yes is not good formacular and retinal cells," he said. Symptoms include headache shortly post-exposure and watering of the eyes, said Dr Adiya Kelkar, director of the National Institute of Ophthalmology. "Regulation is important when such high-powered lasers are used during festivities," he said.
