

PCMC to kickstart auction of 100 sealed properties

Civic body will be starting the process despite record tax collection in first 6 months of fiscal

PUNE, OCTOBER 3

STARTING this month, the property tax department of the Pimpri-Chinchwad Municipal Corporation will auction 100 properties, which collectively owe the civic administration Rs 10 crore as property tax dues. Even though it has registered record-high tax collection in the first six months of the fiscal year, the department is keen to clear its property tax dues.

To increase its revenue collection from property tax, the civic body has also decided to charge two per cent penalty from October 1 on those who are yet to clear their property tax dues. "We will start auctioning sealed properties from this month itself. Currently, the auction process is underway," Nitesh Deshmukh, assistant municipal commissioner, who heads the property tax and assessment department, told this paper.

Deshmukh said the 100 properties that have been sealed are either residential, commercial or industrial. "These properties owe the PCMC Rs 10 crore in dues. The tax on these properties was due not for one but several years. The owners of these properties were given ample opportunities to clear their dues but they failed to pay the property tax. Hence, we sealed the properties of the tax defaulters and are now going to auction them," said the municipal chief.

EXPENSES MORE THAN DOUBLE THE ALLOCATION

PMC's annual budget falls short of meeting medical expenditure of staff, ex-corporators

THE PUNE Municipal Corporation's tall claims of a realistic annual budget for the fiscal 2023-24 have fallen flat as the provision for medical expenses of its staff, retired staff and former corporators was exhausted within a few months of the financial year as the new projection is triple that of what it had estimated for the year.

The civic administration had made a budgetary provision of Rs 20 crore for incurring medical expenditure of its staff and retired staff of hospitalisation in registered private hospitals. "The PMC has received bills worth Rs 19 crore from private hospitals for medical treatment of civic staff by retired staff. A payment of Rs 16.51 crore has been done to clear the bills of February-March of the previous financial year and April-May of this fiscal," said municipal commissioner Vikram Kumar.

The civic chief has moved a proposal seeking diversion of Rs 40 crore to bear the medical expenditure of staff and retired staff for the remaining part of this financial year. There is a need of total Rs 59 crore to bear the medical expenditure of the current and the retired staff, said the civic chief. "The PMC had made a budgetary provision of Rs 40 crore to start health insurance policy for civic staff, retired

staff and former corporators. However, that money has not been spent as of now and is unlikely to be spent this financial year. So, the amount should be transferred to pay for the medical expenditure of the current and retired staff," said Kumar.

The PMC had also set aside Rs 2 crore to bear the medical expenditure of former corporators but the amount lasted only till July while a claim of Rs 1.57 crore needs to be cleared.

"There are efforts to divert funds meant for other purpose to pay for the medical expenditure of former corporators. We need additional Rs 2 crores for the purpose to meet expenses till the end of the financial year," said the municipal chief.

Kumar added that the corpus of Rs 2 crore set aside for medical expenditure of sitting corporators is being diverted as the funds are unlikely to be used since currently, there are no sitting corporators in the civic body due to the delay in elections.

Eye experts raise concern over harmful effects of laser lights used during festivals

THE LARGE-SCALE use of high-powered laser lights during the recently concluded Ganesh festival has flagged concerns among ophthalmologists with experts stating that the use of laser lights is dangerous for the eyes and can lead to direct exposure to such lights.

Addressing a media conference on Tuesday, Dr Anil Dhadhabe, an ophthalmologist based in Pune and retina specialist, said exposure to high-powered lasers can lead to retinal hemorrhage.

"Anyone who focuses on a laser of 5 MW for even ten seconds can suffer from retinal hemorrhage," said Dr Dhadhabe adding that it can cause a blinding effect. He cited the example of a 23-year-old man, who suffered retinal damage due to exposure to high-frequency laser and has lost 70 per cent vision in his eye, which could not be restored even after surgery. Dr Dhadhabe said that the man's blood vessel burst, due

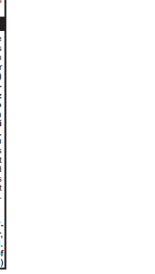
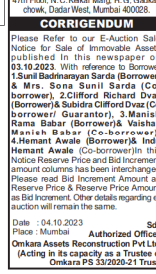
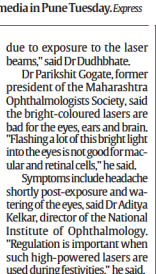
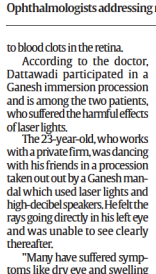
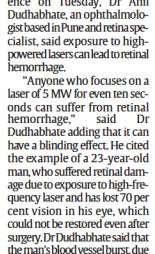
to blood dots in the retina. According to the doctor, Dattawadi participated in a Ganesh immersion procession and was among the two patients, who suffered the harmful effects of laser lights.

The 23-year-old, who works with a private firm, was dancing with his friends in a procession taken out by a Ganesh mandal which used laser lights and high-decibel speakers. He felt the rays going directly in his left eye and was unable to see clearly thereafter.

"Many have suffered symptoms like dry eye and swelling due to exposure to the laser beams," said Dr Dhadhabe. Dr Parikshit Gogate, former president of the Maharashtra Ophthalmologists Society, said the bright-colored lasers are bad for the eyes, ears and brain. "Flashing a lot of this bright light into the eyes is not good for macular and retinal cells," he said.

Symptoms like headache, shorty post-exposure and watering of the eyes, said Dr Aditya Kelkar, director of the National Institute of Ophthalmology. "Regulation is important when such high-powered lasers are used during festivities," he said.
