Goalpara on Solmari-Goalpara road, Goalpara district, insurgents ambushed them, blasting an IED and opening fire. One vehicle was severely hit, injuring its occupants. Despite their injuries, the CRPF troopers retaliated, forcing the insurgents to flee. Five brave troopers Shaheed HC Punam Chand, Shaheed HC M Venkatachalam, Shaheed L/Nk T Nageshwara Rao, Shaheed Ct Randhir Singh and Shaheed Ct Mangal Layek sacrificed their lives on same day while one braveheart Shaheed Ct Manoranjan Bora succumbed to his injuries on 2nd August attaining martyrdom.
