

Elusive tigress captured from human settlement in Kerala

An elusive tigress that triggered panic near Moolamkavu, under the Wayanad Wildlife Sanctuary (WWS) in Kerala, was captured from a human settlement on Monday morning. The tigress, aged about 12, had killed two domestic animals and 50-odd fowls in a poultry farm in the past few days. The predator was shifted to the forest veterinary laboratory at Sulthan Bathery on the directive of K.J. Martin Lowel, warden incharge of the sanctuary.

Notify election of D. K. Aruna as Gadwal MLA: EC order

The Election Commission has ordered publication of gazette notification on the election of D.K. Aruna from Gadwal constituency in the 2018 Assembly elections. The order follows the declaration of the Telangana High Court that Ms. Aruna was the returning candidate from the Assembly with effect from December 12, 2018. The court gave the orders after hearing the Ms. Aruna's plea against BRS' leader Bandla Krishna Mohan. His election had been declared 'void'.

Protest erupts over murder of 4 persons in Tiruppur

After the gruesome murder of four members of a family on Saturday by some inebriated men, a protest demanding the assailants' arrest broke out at Palladam town in Tiruppur on Monday. The victims were hacked to death in Kallakinaru village. The police said one person had been arrested while two others were on the run. The protesters led by the BJP and its affiliates (as one of the victims was allegedly a BJP member) raised slogans against the State government.

Won't be intimidated by 'evil forces': Udhayanidhi Stalin

Speaking at Thoothukudi, DMK leader insists he had not spoken against Hinduism or Hindus; says he condemns the evil practices and inequality encouraged by Sanatana Dharma

sserting that there was nothing wrong in his speaking against Sanatana Dharma, Tamil Nadu Minister for Sports and Youth Welfare Udhayanidhi Stalin on Monday said he would speak against it again and again if he was intimidated to not speak about it. The DMK youth wing leader insisted he had not said "anything against Hinduism and Hindus".

Mr. Udhayanidhi, who was in Thoothukudi to chair a review meeting at the Collectorate, told jour-

nalists there was no need for him to resign his post as there was nothing wrong in what he had said about Sanatana Dharma. "Since Sanatana Dharma promoted the evil practice of sati and treated women like slaves, the Dravidian movement opposed it and liberated women from these nauseating practices and superstitious beliefs," he contended.

"I want to make it clear that I did not speak anything against Hinduism and the Hindus. I condemn the evil practices and inequality encouraged by Sanatana Dharma. If these evil forces threaten me that I should not speak against it, I will speak against Sanatana Dharma again and again," he said. The Dravidian Model of governance in Tamil Nadu has taken women to the next level through a range of schemes including Puthumai Penn scheme that ensures disbursal of ₹1,000 as monthly assistance while the beneficiaries do their graduation, he said. He distributed welfare assistance to the tune of ₹6.37 crore to 115 beneficiaries.

VSSC exam fraud: police gather evidence against 'established racket'

The investigation into the Vikram Sarabhai Space Centre (VSSC) examination fraud has blown the lid off a well-entrenched racket involving Indian Army and Defence Research and Development Organisation (DRDO) staffers which is suspected to have orchestrated similar malpractices with hired test takers in other public examinations.

The Kerala Police have apprehended 10 Haryana natives, including four fake candidates, in the case thus far. Another 15 impersonators are suspected to have appeared for the examination held to various posts on August 20 at various centres in Thiruvananthapuram.

Swiftly apprehended

While the Thiruvananthapuram police moved swiftly to apprehend six persons within two days of the examination, a special investigation team managed to nab four more people from

Haryana. While seven of them are currently in police custody, steps have been initiated to obtain custody of the others.


The sleuths have gathered evidence that indicated that all the accused are known to each other. Bolstering such findings is the seizure of original certificates of candidates from the impersonators, screenshots of question papers and payment details that could prove key in establishing the conspiracy.

Amit, one of the ac-

cused who is currently in custody, is an Army clerk stationed at Mohali in Punjab. He had allegedly impersonated one Rishipal, who had registered for the written test.

"There are reasons to believe that the motley gang had established itself as an efficient network that could be hired by economically backward candidates to appear for examinations on their behalf," said District Police Chief (Thiruvananthapuram City) C.H. Nagaraju.
