Rajasthan's border areas on high alert, schools shut

FOLLOWING INDIA'S strikes on terrorist infrastructure in Pakistan and Pakistan-occupied Kashmir, all border areas of Rajasthan have been put on high alert.

Taking precautionary measures, Bikaner and Jodhpur airports have been closed and flights have been cancelled.

Among other measures taken were the shutting of all schools, both government and private, for Wednesday in Bikaner, Jaisalmer, Barmer and Sri Ganganagar districts.

Barmer Collector Tina Dabi told The Indian Express, "We have decided to shut down the schools to avoid any mishap in case the situation escalates. The annual exams for classes 9 and 11 were going on, and they have been called off as well. A mock drill will start as per the planned timing of 4 pm. All the border districts have

Across states, chorus from Pahalgam victims' kin: 'Been waiting for this day'

FROM HARYANA to Kerala, from Arunachal Pradesh to Andhra Pradesh, the families of the Pahalgam attack victims, who come from across the country, said they felt a sense of justice after India carried out Operation Sindoor, hitting nine sites in Pakistan and Pakistan-occupied Kashmir with airstrikes.

The strikes came two weeks after the April 22 terror attack in south Kashmir's Pahalgam, in which 25 tourists and a local man were killed. The Defence Ministry said in a statement early Wednesday that the airstrikes were undertaken as part of the "commitment that those responsible for this attack will be held accountable"

The father of Lt Vinay Narwal, who was killed in the Pahalgam attack, thanked the government for carrying out the airstrikes. "It was expected for many days. I thank our Prime Minister Narendra Modi and our Armed Forces for their decisive and targeted response. I saw the news reports in the early hours. It is an appropriate action. People had been asking me what I want from the government. This is the befitting reply given to terrorists and their facilitators," said Rajesh Narwal, from Haryana's Karnal.

Recalling going to collect his son's mortal remains, Rajesh said, "It was like a tsunami that had hit my life. At the same moment, a

BAP MLA sent to judicial custody

Jaipur: The Anti-Corruption Branch (ACB) court on Wednesday sent the Bharat Adivasi Party (BAP) MLA Jaikrishn Patel and his middleman Vijay Kumar to judicial custody in a bribery case, an official said. The court has also sent the two other accused, MLA's aide Jaswant alias Lakshman Meena and Jagram, to a two-day police remand. MLA's PA Rohit Meena is still being searched, officials said.

by terrorists in Pahalgam. Niraj and Aayushi got married in February 2023, and had no children
