

Telangana BC Commission Urges Action Against Illegal VDCs

Hyderabad(TSIT): The Telangana Backward Classes Commission has raised concerns over the social exclusion of BC communities by certain Village Development Committees (VDCs) in Nizamabad and Nirmal districts. These issues came to light through public hearings conducted in former district headquarters.

Chairman of the BC Commission, G. Niranjan, has condemned these acts,



calling them violations of fundamental rights. Taking the matter seriously, the Commission has written to the Telangana DGP, urging immediate and strict action against such illegal

committees to prevent recurrence of such incidents. The Commission emphasized the need to uphold the rights of marginalized communities and called for accountability in addressing these discriminatory practices. The issue has also been brought to the attention of caste organizations and the general public to ensure greater awareness and collective action against social exclusion.

Telangana State Deputy Collectors Association Condemns Dilawarpur Incident

Hyderabad,(TSIT): The Telangana State Deputy Collectors Association has strongly condemned the unlawful confinement of Revenue Divisional Officer (RDO) Smt. Ratna Kalyani in Dilawarpur, Nirmal district, on Tuesday. Smt. Kalyani had visited the village to mediate a protest against the proposed construction of an ethanol plant between Dilawarpur and Gundampalli villages, following instructions from the District Collector. Despite her efforts to resolve the issue peacefully, she was obstructed by protestors, who confined her inside her vehicle for several hours, adversely affecting her health.

The protestors also reportedly damaged the RDO's official vehicle, prompting police intervention. The Telangana State Deputy Collectors Association condemned this act as "highly repre-

hensible," highlighting that such aggression undermines governance and demoralizes public servants.

The incident follows a recent attack on revenue officers in Lagacharla, raising concerns over the safety of government officials. The association, however, stated that such attempts would not deter officers from carrying out their duties and reaffirmed their commitment to public service.

Sri K. Chandra Mohan, President of the Association, extended his support to Smt. Kalyani and urged the government to take immediate action against those responsible for the incident. He also called for measures to ensure the safety of public servants in the future. The association appealed to the public to express grievances through lawful and peaceful means.
