

# HC refuses to quash POCSO case against ex-CM Yediyurappa

BENGALURU, FEBRUARY 7

THE KARNATAKA High Court Friday quashed a special court's order taking cognizance of the case against former Karnataka chief minister B S Yediyurappa, 81, under the POCSO Act, but allowed the criminal proceedings against him to continue.

In his plea, Yediyurappa, who was accused of sexually inappropriate behaviour by the mother of a teenager in March last year, had sought the quashing of the case as well cognizance taken of the case by the special court on July 6 last year. Yediyurappa had been summoned to appear in the special court before the framing of charges.

"The writ petition is allowed in part. The order of taking cognizance by the concerned court dated July 6, 2024 qua accused number one stands obliterated. The crime, the investigation and

the concerned court to pass appropriate orders on the final report so placed before it by the CID bearing in mind the observations made in the course of the order," Justice M Nagaprasanna

"It is made clear that this court has not answered any of the contentions advanced by petitioner and respondent except with respect to taking cognizance. All other contentions would remain open. The petitioner is at liberty to avail of remedy as is available under law at the appropriate stage before the appropriate forums," the HC said in the summary of the order.

The development means that the special court will have to reconsider the chargesheet before deciding to summon Yediyurappa to start the trial process in the POCSO case.

New Delhi: The Supreme Court Friday refused to intervene with the Kerala HC order directing the police to register cases on complaints of sexual exploitation in Malayalam cinema, raised before Justice Hema Committee.

A three-judge bench presided by Justice Vikram Nath, said that "under criminal jurisprudence, once information is received or otherwise and the officer in charge of the police stacognizable offence has been committed, he is duty bound to proceed in accordance with the law as prescribed under Section 176 BNSS." The bench also comprising

Justices Sanjay Karol and Sandeep Mehta said, "There can be no direction to injunction or restrain the police from proceeding in accordance with the law."
