New Ukkadam flyover develops cracks, contractor pulled up

THE contractor who has been carrying out the Ukkadam Flyover project works was served a notice by officials over the poor quality of work. As the flyover's surface started developing cracks before the inauguration, officials have taken action.

Cracks were found on the tar road at several places on the access road to the Selvapuram bypass from the flyover near the Sungam Junction.

The Ukkadam-Aathupalam flyover project is being executed on behalf of the state highways department at an estimated cost of ₹360 crore. The project works which were kick-started in 2018 have entered the final stage now with painting works now on.

As reported by the *TNIE* the other day the internal auditing committee of the highways department which comprises officials from other divisions in the state, inspected the Ukkadam flyover project on Thursday. The officials inspected ramps, pillars, roads and other works.

Speaking to *TNIE*, a senior state highways department official said, "A notice has already been issued in this regard to the contractor who has been executing the project. The contractor has been instructed to rectify this issue and fix the cracks immediately. Repair works will begin soon. Meanwhile, we have planned to finish the project work completely by June 30. Currently, about 50% of the demolition work of the TNSTC building in the Sungam bus depot has been finished."

514 school buses cleared for use in Tiruppur

THE annual inspection of private school buses ahead of the new academic year was carried out in Palladam on Friday. Tiruppur Sub-collector Sowmya Ananth inspected the vehicles on the open ground in Madhavpur village.

Around 686 buses from private schools from Tiruppur North, Kangeyam, Avinashi, Tiruppur South and Palladam were subject to checks. In the end, 514 buses passed the inspection.

Around 172 buses were found with defects, but these defects were minor such as non-refilling of fire extinguishers, lack of first aid, etc. The school managements which own the buses were mandated to correct these defects within 20 days. On May 31, these buses must be presented again for inspection

Don't invest in MYV3Ads, police caution people

AFTER receiving reports that several people are continuing to invest in the alleged fraudulent MLM firm MY V3 Ads Media Private Limited, the Coimbatore city police has warned public that the firm has been booked in a cheating case and is facing legal proceedings.

On January 19, Coimbatore City Crime Branch booked the firm and its managing director M Sakthi Anandhan (51) under the Prize Chits and Money Circulation Schemes (Banning) Act and Banning of Unregulated Deposit Schemes Act. In March, Police arrested SV Vijayaragav, owner of a firm that was supplying Ayurvedic products to the MYV3Ads. They are out on bail and the case has been transferred to the Economic Offence Wing (EOW) police. Police said information is spreading on social media that people are still investing money in the firm, and warned them that their investment is illegal and fraudulent.
