Heavy security cover in view of farmers' protest

Stating that machines, medicines and man-power are "woefully inadequate" in Delhi government and MCD hospi-tals, the Delhi High Court tals, the Delhi High Court on Tuesday constituted a six-member expert com-mittee to examine these issues and place a month-ly report before it. A bench headed by Acting Chief Justice Manmohan remarked that authorities vested with the power to run, administer and man-age the hossitals in Delhi

The court took "judicial notice" of the fact that the Municipal Corporation of Delhi (MCD) finds it dif-ficult to pay salaries and pension to its employees and although the 7th Pay Commission has come into force, the benefit of the enhanced pay or pen-sion has not been given to MCD employees.

"Consequently, this court is of the view that it is very unlikely that the MCD has the wherewithal to make huge investment in the infrastructure of eight hospitals under its man-agement," the court observed. Besides, women commuters are facing difficulty in looking for pub-lic restroms amid the heavy traffic.

I have to catch a flight for Bengaluru and now T ms stuck in traffic which is moving at a snaït space, she complained. A family said that they have been waiting in the long traf-fic since morning. Twe now feel frustrated and exhausted. We have small kids with us, they are also hungry. There is no food and water available nearby. What should we do? said a member of the family.
