EFFORTS to develop the tourism sector in the district are set to take shape by August, with officials urged to expedite the implementation of proposed projects, said district collector P Prasanthi.

The District Tourism Committee (DTC) meeting was held on Wednesday at the District Collector's camp office under the chairmanship of the collector. In-Charge District Forest Officer Ravindra Dama, District Revenue Officer T Seetharama Murthy, and other officials attended the meeting.

Speaking at the meeting, collector Prasanthi emphasised the need to identify various agencies for the development of tourism projects in the district and to take necessary actions with special proposals. She directed that tourism development should be carried out in a phased manner with strategic planning.

As part of this initiative, the first phase of a boating facility covering one kilometre in Kadiyapulanka will be implemented, with plans to gradually extend its length. She also instructed officials to identify

Govt urged to listen to woes of chilli farmers

FORMER MLA Malladi Vishnu criticised the NDA government for its miserable failure in solving the problems of chilli farmers.

Speaking to the here on Wednesday, he said that the government remained a silent spectator to the problems of chilli farmers when the falling prices of chilli are worrying them.

He recalled that the chilli farmers had earned profits in the last four years but this year they suffered heavy loss. Chilli was cultivated in about 1.96 lakh hectares in Krishna, Guntur, Prakasam, Kurnool, Nandyala, Anantapuram and Kadapa districts this

The yield had come down drastically to ten to 15 quintals per acre due to the virus attack. The chilli was cultivated in 8,000 acres in Nandigama constituency last year but this year it was only in 5,374 acres. The yield has come down drastically and the expenses have gone up forcing the farmers to invest Rs 1.5 lakh per acre. The farmers are worried over the falling chilli prices.

The farmers used to get record prices of Rs 25,000 per quintal during the YSRCP regime, Malladi recalled. "Now they are hardly getting Rs 13,000, which is pathetic," he said.

On the other hand, the traders are lining their pockets in the name of

commissions. He demanded the government to provide remunerative prices for all the crops including mirchi.
