RAVI UNFIT TO BE GOV, SAYS DMK

MPs of DMK-led alliance urge President Droupadi Murmu to remove Governor R N Ravi

Tamil Nadu Governor RN Ravi's 'blatant refusal' to accede to Chief Minister M K Stalin's request to appoint legislator and senior DMK leader K Ponmudy as the Higher Education Minister is violative of the Constitution and he is unfit to hold the post, the ruling DMK has said.

Stalin had earlier written to Ravi, recommending the re-induction of Ponmudy in the cabinet to the same portfolio he had held prior to his conviction in a disproportionate assets case by the Madras High Court. However, Ravi had refused to do so, following which the state government moved the Supreme Court on the matter on Monday.

DMK Rajya Sabha MP and senior advocate P Wilson said the Governor is proving to be a "repeat offender and is acting with scant regard to the Constitution." The Tamil Nadu

TN Govt moves SC after Governor refuses to reinstate Ponmudy as minister

NEW DELHI: The Tamil Nadu Government on Monday moved the Supreme Court to challenge the decision of Governor RN Ravi, who refused to reinstate Dravida Munnetra Kazhagam leader and MLA K Ponmudy as a minister in the state cabinet. Senior Advocate AM Singhvi mentioned the plea seeking an urgent hearing before the bench led by Chief Justice of India DY Chandrachud, who assured him that the bench would see it.

In the plea, the Tamil Nadu government has urged the top court to issue directions to appoint Thiru K Ponmudi as a Minister of the Government of Tamil Nadu. "When he has stooped to the levels of willfully violating orders of the Supreme Court, desecrating the Constitutional provisions, and ignoring the rule of law, he is not fit to hold the post any longer," the senior advocate said in a post on X.

Meanwhile, the Supreme Court on Monday agreed to consider a plea of the Tamil Nadu government against the refusal of Governor Ravi to appoint Ponmudy as a minister in the state cabinet.

When the conviction order of the High Court is "suspended" by the apex court, it means that the order is non-existent in the eyes of law.

"This interpretation accorded by the Governor cannot be a mere ignorance of law but wilful and wanton violation of the order of the SC for which the Governor must be prosecuted for contempt," Wilson said.

Biggest scam of year, says Baghel

RAIPUR: Taking the attack to the BJP over the Centre's now-junked Electoral Bond Scheme, a day after the Election Commission (EC) notified the dates for the Lok Sabha elections, former Chhattisgarh Chief Minister and Congress leader Bhupesh Baghel on Sunday called it the "biggest scam of the year."

Speaking to reporters on Sunday, the Congress leader said, "This is the biggest scam of the year. The BJP senses that it is losing the Lok Sabha elections and was, hence, resorting to newer tactics against the Opposition."
