# Summit talks with Xi in Oct, Trump to visit China next year

Boosting trade, TikTok, fentanyl crisis among issues discussed, along with ways to end the Ukraine war

#### WASHINGTON

US President Donald Trump said he would meet Chinese President Xi Jinping at a regional summit to take place at the end of October in South Korea and will visit China early next year, following a phone call with his Chinese counterpart on Friday.

In a Truth Social post, Trump also said the Chinese leader would come to the United states "at an appropriate time," noting the leaders also made progress on "the approval of

"The call was a very good one, we will be speaking again by phone, appreciate the Tik-Tok approval, and both look forward to meeting at APEC!" Trump wrote, referring to the Asia-Pacific Economic Cooperation, a grouping of 21 economies on the Pacific Rim.

Neither Trump nor a readout of the call from Chinese state media gave any details on what was discussed about TikTok. TikTok did not immediately respond to The Associated Press' request for more details on the call or the framework deal.

China's official news agency Xinhua said Xi, in the call, stressed the importance of the bilateral ties and urged the US side to avoid any unilateral trade restrictions.

This is the second call with Xi since Trump returned to the

White House and launched skyhigh tariffs on China, triggering back-and-forth trade restrictions that strained ties

between the two largest economies. But Trump, a Republican, has expressed willingness to negotiate trade deals with Beijing, notably for TikTok, which faces a US ban unless its Chinese parent company sells its controlling stake. Trump said the two made

progress also on "many very important issues including Trade, Fentanyl, the need to bring the War between Russia and Ukraine to an end," besides the TikTok deal. The two men also spoke in June to defuse tensions over China's restrictions on the export of rare earth elements, used in everything from smartphones to fighter jets. Trump on Thursday said his relationship with China is "very good" but noted that Russia's war in Ukraine could end if European countries put higher tariffs on China. Trump didn't say if he planned to raise tariffs on Beijing over its purchase of Moscow's oil, as he has done with India. Before the call, Liu Pengyu, spokesperson for the Chinese embassy in Washington, said "heads-of-state diplomacy plays an irreplaceable role in providing strategic guidance for China-U.S. relations."

Sun Yun, director of the China program at the Washingtonbased think tank Stimson Center, had predicted a positive discussion."Both sides have strong desire for the leadership summit to happen, while the details lie in the trade deal and what can be achieved for both sides from the summit," Sun said. Top US and Chinese officials have held four rounds of trade talks between May and September, with another likely in the coming weeks. Both sides have paused sky-high tariffs and pulled back from harsh export controls, but many issues remain unresolved.

## Oli says didn't give firing orders in Nepal 'GenZ' protests

NEPAL's deposed prime minister K P Sharma Oli on Friday denied that he had given any shooting orders during the 'Gen Z' demonstrations, saying bullets were fired at protesters from automatic guns that the police did not possess and called for a probe into the matter.

In his first public statement since his ouster on September 9, the Communist Party of Nepal (Unified Marxist-Leninist) chairman blamed the infiltrators for the violence during the "peaceful protest" by Gen-Z.

"The government didn't order to shoot at the demonstrators," Oli said in a message issued on the occasion of Constitution Day.

"The bullets were fired at the protesters from automatic guns, which were not possessed by police, and this must be investigated," Oli said.

Seventy-four people, including three policemen, were among the dead during the youth-led violent protests on September 8 and 9 against corruption and a ban on social media. Claiming that there was "infiltration", he said, "The conspirators turned the agitation violent, and this way our

### **Trump seeks court backing** on transgender rules

WASHINGTON: The Trump administration has asked the Supreme Court to allow enforcement of a passport policy requiring sex designations to match birth certificates, blocking transgender and nonbinary people from using "X" markers. A lower-court order had paused the rule after lawsuits called it discriminatory. The Justice Department argues only "male" or "female" markers are valid.

## Beijing, Kabul dismiss Trump's plan to retake Bagram air base **BEIJING/KABUL**

CHINA and the Taliban on Friday rejected US President Donald Trump's proposal to reclaim Afghanistan's strategic Bagram air base near the Chinese border, with Beijing cautioning against efforts to stir regional confrontation and Kabul reiterating that Afghans never accepted foreign military presence.

The sprawling Bagram air base was abandoned by American troops four years ago in 2021 during their chaotic withdrawal ordered by then president Joe Biden, as Taliban militants took control of Kabul.

Trump, speaking at a joint press conference in the UK with British Prime Minister Keir Starmer, on Thursday said he was trying to get the base back

Reacting to Trump's remarks, Taliban official Zakir Jalal said the interim Afghanistan government "completely rejects" the idea. Afghanistan and America need to engage

spect and common benefits, without America having military presence in any part of Afghanistan, he said on X.

"Military presence has never been accepted by Afghans in history, and this possibility was completely rejected during the Doha talks and agreement, but doors to other engagements have been opened," Jalal added.

China too conveyed its opposition to Trump's remarks, with Foreign Ministry spokesperson Lin Jian telling a media briefing in Beijing that "stirring up tension and confrontation in the region will not be supported".
