How lovers of the Mandolin are preserving its melody

IN HIS 20's, Anil Pendse decided to learn the guitar. But when he went to the classes he heard his instructor say, "Why is every single student here trying to learn guitar? Somebody also give the Mandolin a shot!". So Pendse did and fell in love with it. "I also turned towards it because it is not very popular and hasn't been given its due importance," he said. Pendse is the founder mem-

ber of the Mandolin Lovers Club, established in 2002 in Pune. The club aims to popularise the instrument through shows, workshops, seminars, etc. But its biggest platform to promote the instrument has been the Mandolin Festival. The 7th Mandolin Festival

was held this year on November 29 at President, Karve road. Over the years, its editions were organised across cities like Kolhapur, Goa and Bangalore. It was because of this festival that every year 10 to 20 artists join the club and today, the club boasts 113 members.

Pradipto Sengupta, one of the leading mandolin players in the country was involved in laving the foundations of the first festival. Held at MIT Vishwashanti Gurukul in Loni, around 50 man-
